Relief to Workers

Atal Beemit Vyakti Kalyan Yojana

- Scheme to benefit workers covered under ESI Act, 1948
- Relief payable in cash directly to the bank account in case of IP being rendered unemployed, while searching for new job.

ATAL BEEMIT VYAKTI KALYAN YOJANA

Features of the Scheme

- Scheme to benefit workers covered under ESI Act 1948;
- Relief payable in cash directly to the account of the Insured persons while seeking job after loss of the employment;
- Employees should have completed 2 years' insurable employment and contributed 78 days in each contribution period before the loss of employment;
- The scheme is effective from 01-07-18 to 30-06-20 on pilot basis;
- Admissible for 90 days during life time@ 25% of the average daily wages;

Disqualification

- During lockout, strike resorted by employees declared illegal by competent authority;
- Voluntary abandonment of employment/VRS/Premature retirement;
- Less than 2 years contributory service;
- Dismissal/termination under disciplinary action;
- Re-employed elsewhere during the period of receipt of ABVKY;
- Convicted under provisions of Section 84 read with Rule 62 (i.e. punished for false statement).
