Subject: - Uniformity in Medical Cards in respect of all Pensioners/ESIC Employees of ESIC.

Sir/Madam,

Following guidelines are hereby laid down to maintain uniformity of Medical Cards in respect of all Pensioners/Employees of ESIC:

(i) All the beneficiaries and their dependents shall be provided Medical cards with photo ID individually with unique Card number which is required to be produced to avail the facilities.

(ii) Such photo ID card shall be plastic based. Size shall be same as that of debit/credit cards issued by Banks. It shall contain black text with white background. However, the colour of the

strip of the top shall be as under:

- (iii) It shall bear the State Emblem on Top Left in Red and ESIC's logo on the top Right.
- (iv) It shall contain 3D Hologram (as supplied by General Branch, Headquarters) on the body of the card partially covering the photo of beneficiary.
- (v) Safe custody of Medical cards is the responsibility of the beneficiary and in case of loss of the card, beneficiary is required to inform the police and card issuing authority.
- (vi) Duplicate Medical card can be obtained against lost card by applying for the same to the concerned issuing authority alongwith the copy of FIR against the charge as decided by the issuing authority.
- (vii) In case of pensioners, head of the office, from where the pensioner is drawing pension, is entrusted for issuing of Identity Cards as well as Medical Cards.

The Sample of Plastic Medical Card is enclosed for ready reference. This is issued with the approval of Competent Authority.
