Candidates should also bring two recent passport size photographs along with proof of residence.

Fee: For General & OBC Candidates fee is Rs. 300/- and for SC/ST is Rs. 75/- in the form of Demand Draft payable at 'New Delhi' in favour of 'ESI Fund A/c no. 01'. There is no fee for women & PWD Candidates.

Terms & Conditions: -

- Private practices of any kind will not be allowed for full time contractual engagements. If found guilty, suitable action as provided under the relevant rules shall be taken.
- **If no candidate appears against the above advertised post as mentioned, then the available candidate of any other category may appear as an SR candidate for 39 days as per requirement & the ESIC regulations.**
- The recruitment will be purely on contractual basis and selected candidates will have no claim for regularization of the service in the hospital.
- Canvassing in any form shall be disqualification.
- The candidate who is in service should submit "No Objection Certificate" from the employer at the time of Interview.
- The decision of the Selection Board will be final on all aspects of selection and no further correspondence will be entertained under any circumstances.
- The posts are contractual. and the contractual engagement may be terminated discontinued by either side giving one-month prior notice to this effect without assigning any reason.
- No claim for any service benefits like PF, Pension, Gratuity, Medical Allowance, Seniority, Promotion will be admissible.
